COMMENTS:

Per plan, production casing was run with a two stage configuration with an external casing packer ("ECP") and DV tool set at 1987 ft. The first stage went as planned. Upon attempting to set the ECP, pressures were not consistent with a good set. The DV tool which was placed directly above the ECP was opened and no circulation was possible indicating the ECP had not set and the fluid was being lost below the surface casing shoe. Linn requests permission to move the drilling rig off and remedy this with workover rig operations within 60 days. Exact plans will be submitted prior to proceeding. Verbal approval was received on 2-17-2015 at 4:20 pm from Dave Andrews.
