COMMENTS:

The Hiawatha B1 well has been shut in for close to 2 years and a mechanical integrity test was performed in February 2015 and failed. A cement squeeze procdure was then attempted to repair the casing without success. A decision was made to plug and abandon the well. Due to wildlife stipulations for the raptors (Feb. 1st - July 31st) and uncertainty of the wellbores condition, Chevron believes it is preferable to proceed with the P&A procedure after the wildlife stipulation is over. This will allow time for a possible complex job to be performed. The perforations are currently isolated with a cast iron bridge plug above the perforations.
