At least one person at the well site during drilling operations will have Mineral Management certification or Director approved training for blowout prevention.
2	Drilling/Completion Operations	604.c.(2)I. - Upon initial rig-up and at least once every thirty (30) days during drilling operations thereafter, pressure testing of the casing string and each component of the blowout prevention equipment including flange connections will be performed to seventy percent (70%) of working pressure or seventy percent (70%) of the internal yield of casing, whichever is less. Pressure testing shall be conducted and the documented results will be retained by the operator for inspection by the Director for a period of one (1) year.
