#### COMMENTS:

A complete gas sample analysis is attached.

Gas was flared for 13 days during a 30-day period beginning July 3, 2014. The average flaring volume during this period was 82.52 MCF/D; volumes were measured daily. A pipeline connection was established on July 8, 2014 and gas has been flowing to sales. Frequency of flaring decreased and ended as the flowback and maintenance phase of the well was completed.

There is a presence of H2S; sampling showed 4.5ppm.
