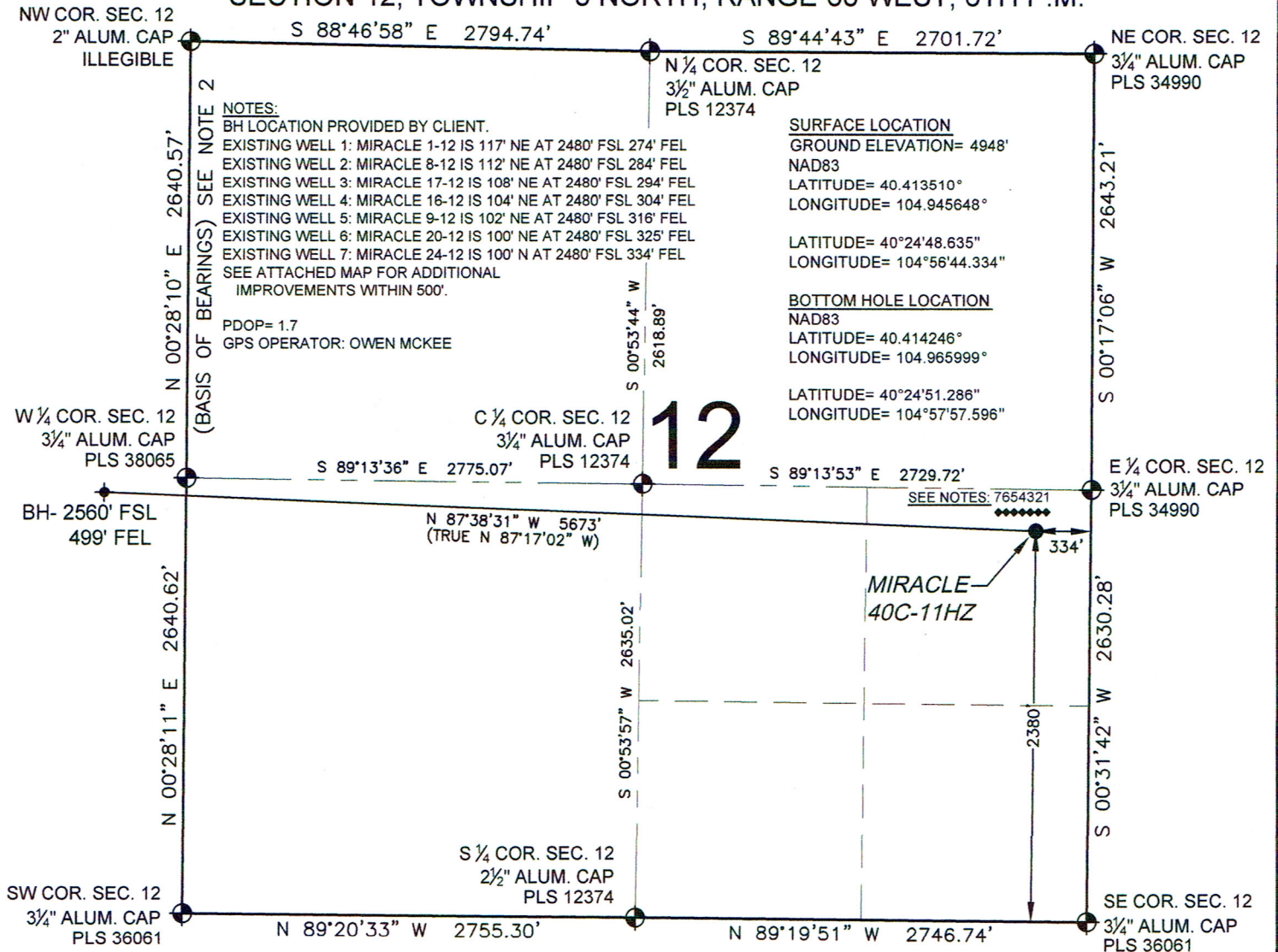


# WELL LOCATION CERTIFICATE: MIRACLE 40C-11HZ

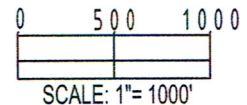

BH = BOTTOM HOLE

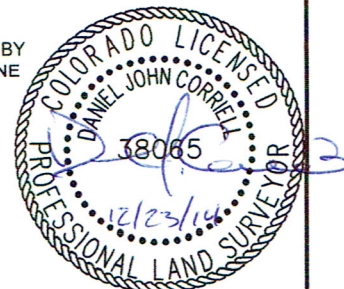

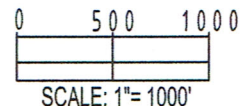

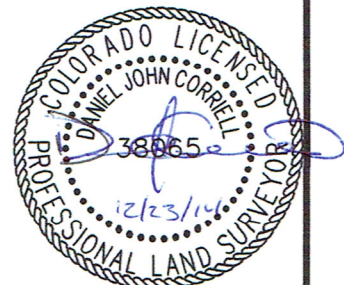
