#### COMMENTS:

Whiting is requesting an amendment to Remediation Plan #8581. The original plan called for all pit remediation activity to be completed by September 2014. However, remediation activity for Remediation plans #8580 and #8579 took longer than anticipated. We were not able to commence activity for plan #8581 due to the on-set of winter weather.

Whiting is requesting that the COGCC grant an extension for plan #8581. We will be able to recommence operations upon the lifting of the load weight restriction to Rio Blanco County Road 5 and favorable weather returns. We anticipate a start date of June 2015 and completion by September 2015. I have discussed this with Stan Spencer regarding this action.
