COMMENTS:

Whiting is requesting an amendment to Remediation Plan #8583. The original plan called for all pit remediation activity to be completed by September 2014. However, remediation activity for Remediation Plans #8579 and #8580 took longer than anticipated. We were not able to commence activity for plan #8583 due to the on-set of winter weather.

Whiting is requesting that the COGCC grant an extension for plan #8583. We will be able to recommence operations upon the lifting of the load weight respriction to Rio Blanco County Road 5 and favorable weather. We anticipate a start date of June 2015 and completion by September 2015. I have discussed this with Stan Spencer regarding this action.
