No	BMP/COA Type	Description
1	Community Outreach and Notification	A business located across the highway and out of site of the wellpad falls in the 1000' buffer zone. Notification was sent to the building owner on on 1/2/15 with the offer of a meeting with BP (attached). No meeting was requested. Notification of the 2A submittal and comment period will be sent upon completion check.
2	Traffic control	Access will be via an access road off of the County Road . Access to the wellsite is granted by the SUA and road ROWs from adjacent landowners. BP will comply with any La Plata County and/or CDOT traffic control measures as required.
3	Storm Water/Erosion Control	Covered in the Field Wide Storm Water Managemant Plan. Site specific SWMPs have been developed for this location and incude the use of wattles and rock rundowns where needed as shown on the attached drawings.
4	Dust control	The access road will be graveled to control dust.
5	Noise mitigation	Noise levels will be monitored by the operator and will meet the COGCC standards. In order to meet the COGCC standards, BP will implement measures such as mufflers or sound walls, if necessary.
6	Interim Reclamation	Wattles will be repaired or replaced as necessary following interim reclamation. Re-seeding will be done as soon as possible following reclamation of the pad with weed free straw mulch. BP will tackify or crimp mulch to the exposed soil surfaces.  Noxious weeds are not significant at this site. Noxious weeds are controlled by an ongoing weed control plan.
