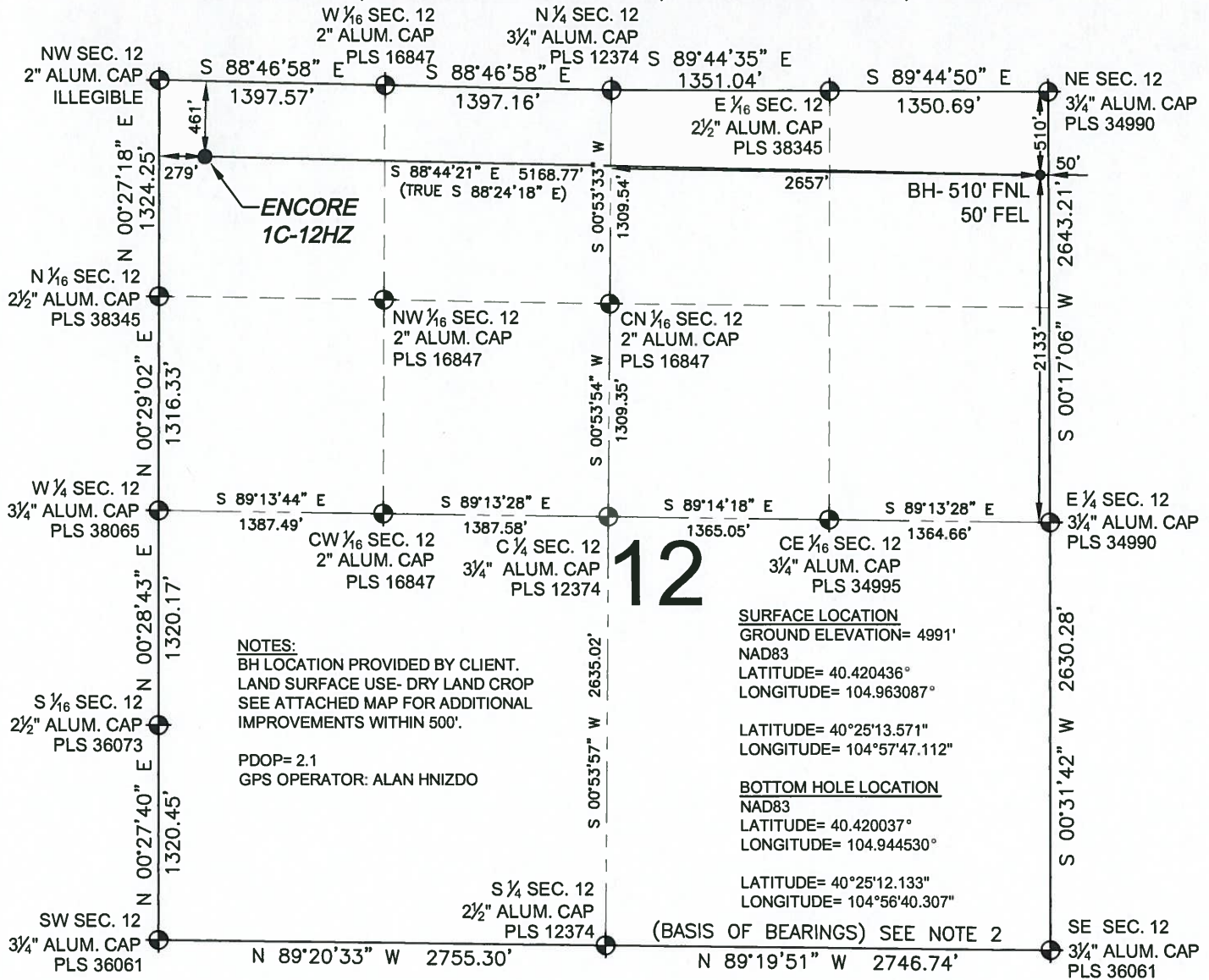


WELL LOCATION CERTIFICATE: ENCORE 1C-12HZ
