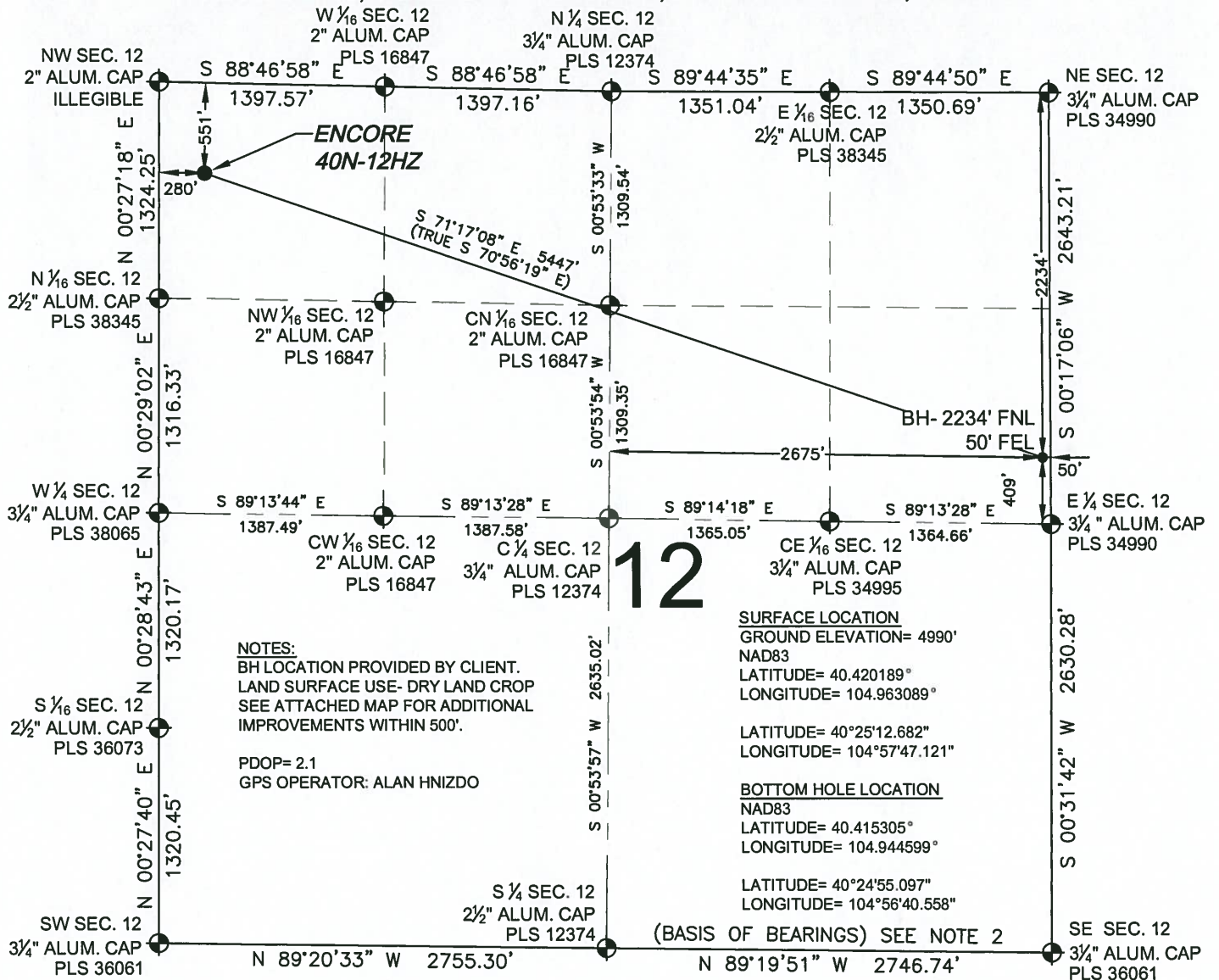


WELL LOCATION CERTIFICATE: ENCORE 40N-12HZ
