1. Set retainer at 2919'
2. Test 5 1/2" casing to 400 psi
3. Mix and pump 40 sx cement (10 sx below retainer and 30 sx above)
4. Perforate 5 1/2" casing at 193', fill hole
5. Mix & pump 92 sx cement. Pump down 5 1/2" and up 10 3/4" until cement returned to surface
6. Cut wellhead off 3' below GL and weld on dry hole marker
7. Cut off deadmen and remove all equipment.
