Due to engineering concerns and emerging data, the top of production, BHL, & SHL of this well has been revised to minimize surface impact and maximize BHL efficiencies. Noble Energy certifies that there are no other changes to the permitted well, other than the BHL, SHL, the top of production, and the total depth of the well. The Lease, Spacing, and Pooling information will not change. Although the distance changed, the nearest well is unchanged from the original permit: Colt A13-633 (API: 123-40911).
