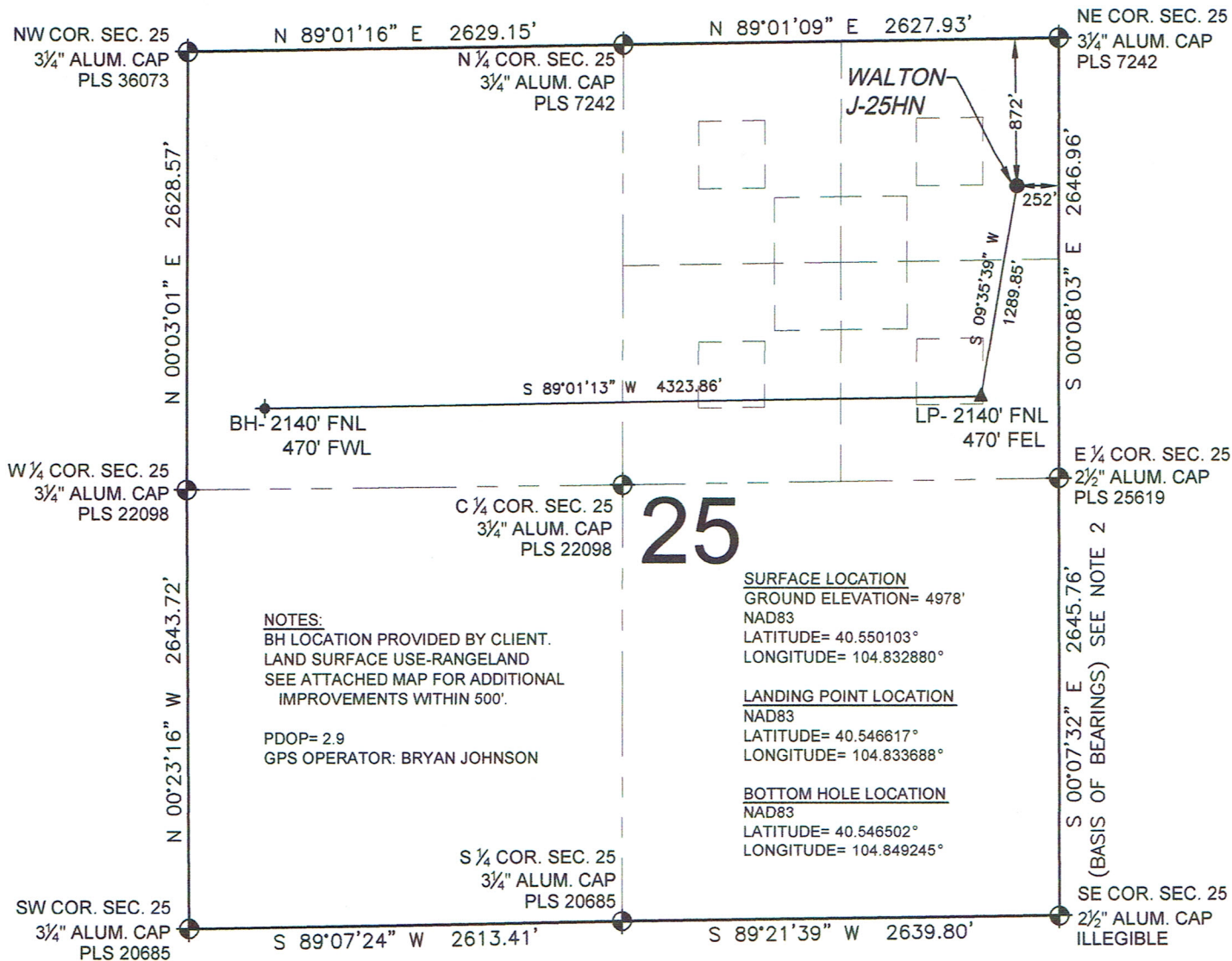


# WELL LOCATION CERTIFICATE: WALTON J-25HN

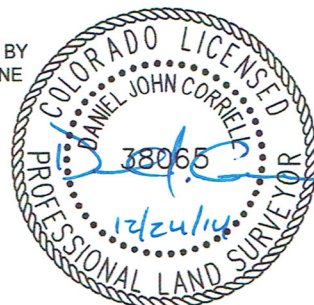
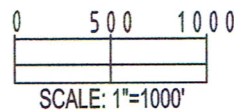
