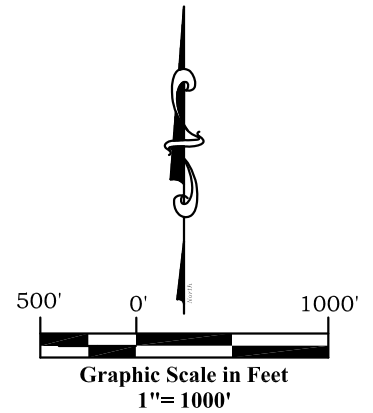


**Note:**
