XTO Energy is providing a status update on this location as instructed by the COAs for Doc #400698552 approved on 10/06/2014.

Due to the amount of imported soil needed to backfill and the need to install and bury flow lines on this location prior to completing backfill, compounded by the time required to compact our excavation during backfill, XTO is estimating that for the soil work will be completed in June 2015 and being able to bring in a rig to evaluate the casing repair in July 2015.
