Please see the below responses to your questions:

1) 6.0 Waste Tracking, Pond inflow is listed at 217,979 bbl vs outflow at 3,520,131 bbls injected and 354,387 recycled. Should the numbers balance or did the injected and recycled water not pass through the pond? The numbers do not balance because not all of the recycled/injected water passes through the Love Ranch 8 Pond. The pond is tied to the Produced Water Distribution and Disposal (PWDD) system throughout the field. The PWDD allows water to be sent to injection wells for disposal and to locations for recycling when needed for ongoing operations. When water production exceeds disposal and recycling volumes it is stored in the Love Ranch 8 Pond. Conversely, when water production does not exceed disposal/recycling volumes water from the pond is sent to injection wells for disposal or to be recycled.

2) Table 1. Lab units are mg/kg for what appear to be both solid and water samples. Please provide units for water samples.
