I was nice talking to you today. Thanks for taking the time to look for documentation concerning the landfarm operation and stockpiles previously existing on the Lundgren pad. That is great but I repeat what I have said previously: Unless documentation exists about confirmation sampling, URSA will need to demonstrate that no impact was left on the pad, specifically in the area covered by the landfarm and stockpiles. Remediation Project #8407 will not be closed and reclamation will not proceed until the COAs are met.

Please submit via e-form 04 a brief sampling plan with a figure indicating the number and location of samples. Enough samples should be taken to characterize appropriately the area covered by the landfarm and stockpiles. Submit the Sampling Plan to the COGCC by **Friday, March 27, 2015**.

This email will be uploaded to the database along with the signed Form 27 supplemental.

Conditions of Approval (COAs):

1) URSA shall provide confirmation sampling of the formerly existing landfarming operation and stockpile areas. (see attached inspection report, doc #668500248, showing the location of the landfarm operation and stockpiles). Or provide documentation that '***All wastes on-site had been managed by the previous owner as an agreement prior to sale***' as stated in the last sentence of the " Notice of Completion Report."
