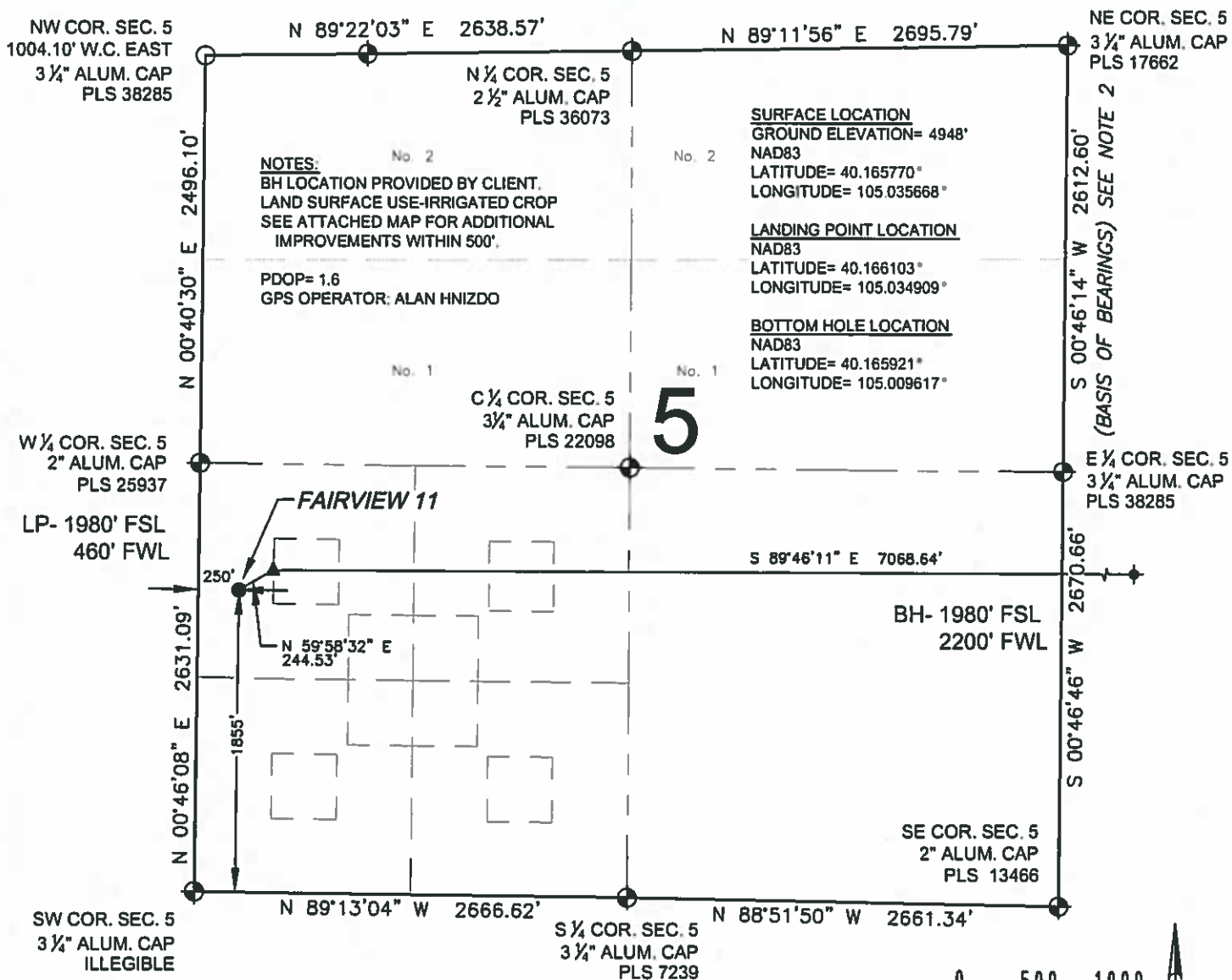


# WELL LOCATION CERTIFICATE: FAIRVIEW 11

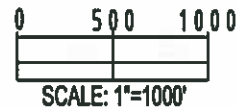

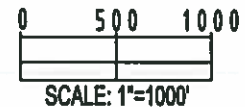
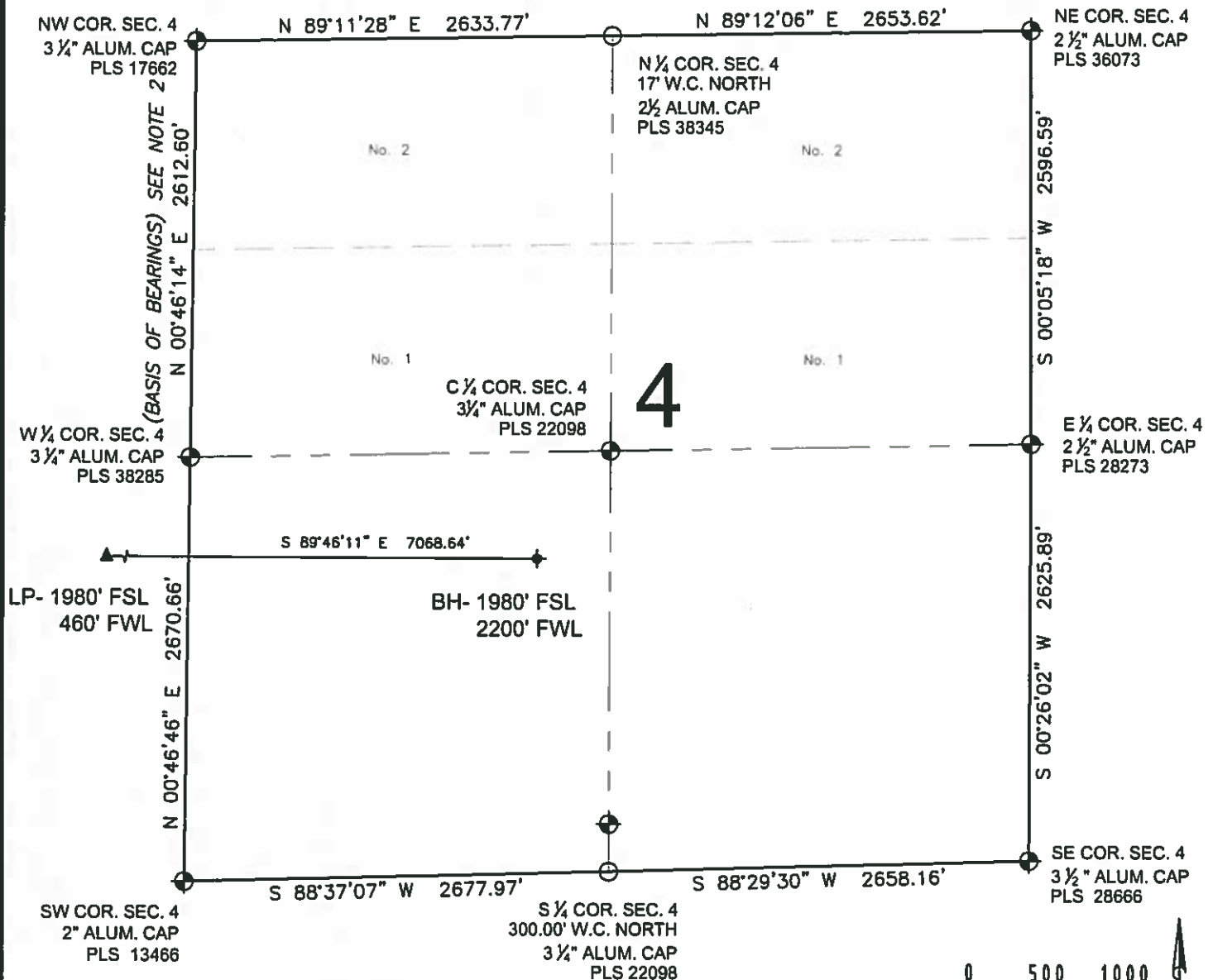
