Bill Barrett Corporation has requested an extension to Rule 1003 Interim Reclamation requirements through November of 2015. There are a total of five wells permitted on this pad in which only one well has been drilled. BBC is currently evaluating production results to determine potential to re-occupy and drill the remaining permitted wells. All stockpiled soils shall be protected from degradation and best management practices to prevent weed establishment and to maintain soil microbial activity shall be implemented.
