Operator Comments:

In response to Insp. 674700814, Encana has inspected the location and addressed the following corrective action item assigned during the inspection: Install berm around 80 bbl tank.

The referenced tank has been placed on location temporarily during maintenance operations. It is expected the tank will be removed from the location in 2-3 weeks (pending weather) when the work is complete. Due to the nature of the tank being temporarily in use, Encana will not be installing a berm around the tank. Per EPA SPCC regulation 40 CFR 112, this location & temporary tank are in compliance. There is a site perimeter berm on this location that provides sufficient general containment and an oil spill contingency plan has been implemented for this location.

Encana requests that the COGCC remove the corrective action requiring a berm immediately around the tank under the premise that there is no COGCC rule pertaining to temporary/mobile tanks and because Encana is in full compliance with EPA's SPCC regulations.
