Analyze drilling fluid for TPH-GRO, DRO, BTEX, Major Cations (Calcium, Iron, Magnesium, Manganese, Potassium, Sodium), and Major Anions (Bromide, Chloride, Sulfate, Fluoride). The characterization shall be representative of the fluids and cuttings at total well depth.
