To ensure coverage of the Upper Pierre Aquifer, Noble proposes the following changes to the subject permit. Revise Surface Casing setting depth from 1680' to 550' and sacks of cement from 815 sks to 173 sks; the Intermediate Casing setting depth remains at 7015' with sacks of cement to be increased from 480 sks to 525 sks.

At the time of spud, Noble will determine whether to lower the surface casing or increase the intermediate casing cement volume as previously noted.
