Comments:

Due to the unstable area (fine sugar sand) it has been an ongoing process to get the area stabilized. Straw had been stitched but did not hold due to winds and very sandy conditions. In the spring of 2014 the area was seeded and we were able to get the area to stop blowing by spreading manure and eventually get weeds established in the fall of 2014. Since the weeds are currently dead we feel there is no threat of them drawing the moisture out of the ground and they are doing a good job covering the area to prevent blowing and are holding the moisture to help with the spring grass growth.

If we disturb the weeds at this time by mowing we run the risk of "breaking" the crust and causing the area to blow again. As spring approaches we will regularly check the area for grass growth and as grass emerges we will hand pull/cut the weeds to allow better grass growth, yet keep the area stabilized and prevent erosion. We will also hand broadcast more seed as needed to get the area re-established in grass, but may need to rely on weeds as a cover crop to protect the delicate, new vegetation.
