COMMENTS:

Chevron has discovered suspected communication in the Rangely Field between the active CO2/Water flooded Weber formation and the Mancos formation resulting in formation gas, consisting of primarily CO2, venting from three plugged and abandoned wells in close proximity, but outside the boundaries of the Rangely Field. The communication is believed, but has not been confirmed, to be through the MB Larson A1 (API#051030632900) well that was plugged in May 1985. Chevron has taken action to shut in the active injection well closest to the suspected problem well. All of Chevron's other active wells in the Rangely Field continue to operate under normal conditions.
