Hey Rebecca,

Per your request, Extraction, has moved some of the facility equipment in order to gain an additional 104' from the nearest facility edge to the nearest BU. Due to that change I have attached an updated location drawing and facility layout. The Cultural setbacks (From Production Facility) have also changed to the following:

Distance to nearest:	Distance	Direction
Building:	714	NE
Building Unit:	826	SE
High Occupancy Building Unit:	5280	NW
Designated Outside Activity Area:	5280	NW
Public Road:	206	SW
Above Ground Utility:	160	SW
Railroad: Feet	5280	E
Property Line:	152	SW

Extraction has reviewed the surrounding areas to identify any technical and economical options outside of buffer zones. As a result of Operator's review of potential locations outside Buffer Zone, the operator has determined that this is the best possible location for the facilities given the surface owner's plans for development to the North, property boundaries, utility easements and current COGCC setbacks.

Can you add the following BMP: Since tanks are within the buffer zone, Operator will utilize Low-profile tanks.

Additionally during our review we found a discrepancy in the Hydrology Map, can you please update the hydrology map with the attached Troutd 32-M Hydrology Map.
