Paul,

Although the losses of fluids from the NGL C4 location are still being investigated, I think it is safe to say that the loss was much greater than 5 bbls and is likely >100 bbls. Even if the material is contained, we need to include the total loss from the primary tanks as well as the trucks on the location.

Please let me know if you/NGL agrees to revising the estimate to >100 bbls with a more precise estimate due on the Supplemental Form 19.
