#### COMMENTS:

Operations to abandon the conductor for this undrilled well were completed on 3/28/15 by Whiting Oil & Gas Corporation.

Details: 16" conductor pipe was cut 5' below ground level, filled with 58 sxs of Class G Neat cement (12 bbls) from a tagged depth of 50', and an ID plate was welded on top. The COGCC was notified, but not on location. Location was backfilled.

As noted on the notice of intent sundry, the pad will not be reclaimed at this time as there is an active well utilizing it.
