Blair,

Based on the review of site information and data provided, it is the COGCCs opinion that surface water monitoring will suffice and monitoring wells will not be required as they relate to this project.

Surface water samples shall be analyzed for: total petroleum hydrocarbons (diesel and gas range organics), benzene, toluene, ethyl-benzene, xylenes, pH, specific conductance, total alkalinity, total dissolved solids, bromide, chloride, fluoride, nitrate, nitrite, sulfate, calcium, iron, magnesium, manganese, potassium, selenium, and sodium.

Alex and Steve – thank you for your help on getting these documents reviewed.

Oxy has not begun reclaiming the Pond 13E and Pond 13W facilities as Garfield County put a COA onto the location indicating that construction cannot occur before July 1 of each year to protect Greater Sage Grouse production areas.

Since we will be requesting to chance a COA with GarCo, Oxy will need a letter indicating that based on topography in the area of the site; the COGCC agrees that surface water monitoring will be preferred as opposed to monitoring wells for this project. Could you prepare a document indicating this to include in our submittal to Garfield County? Once we receive this letter, Oxy will submit the Resolution response document to Garfield County for approval. Once approved, Oxy will provide final GarCo approval to the COGCC. Financial assurance will also be included in the correspondence to the COGCC.
