Step 3. Conduct Bradenhead test. Step 4. Conduct intermediate casing test. Step 5. Send report to BLM within 3 days and to OGCC within 10 days. Include wellbore diagram if not previously submitted or if wellbore configuration has changed since prior program. Attach gas and liquid analyses if sampled.

SURFACE CASING PRODUCED 13 GALLONS OF WATER DURING FORM 17 TEST. MONITORED THE SURFACE CASING AN EXTRA 30 MINUTES. PRESSURE STAYED AT A WHISPER OF GAS. SHUT SURFACE CASING IN FOR 15 MINUTES. PRESSURE BUILT UP TO 11 PSI.  
POST REMEDIATION BLOW-DOWN ON 4-14-2015. PRESSURE WAS AT 131 PSI AND BLEW-DOWN TO A WHISPER.
