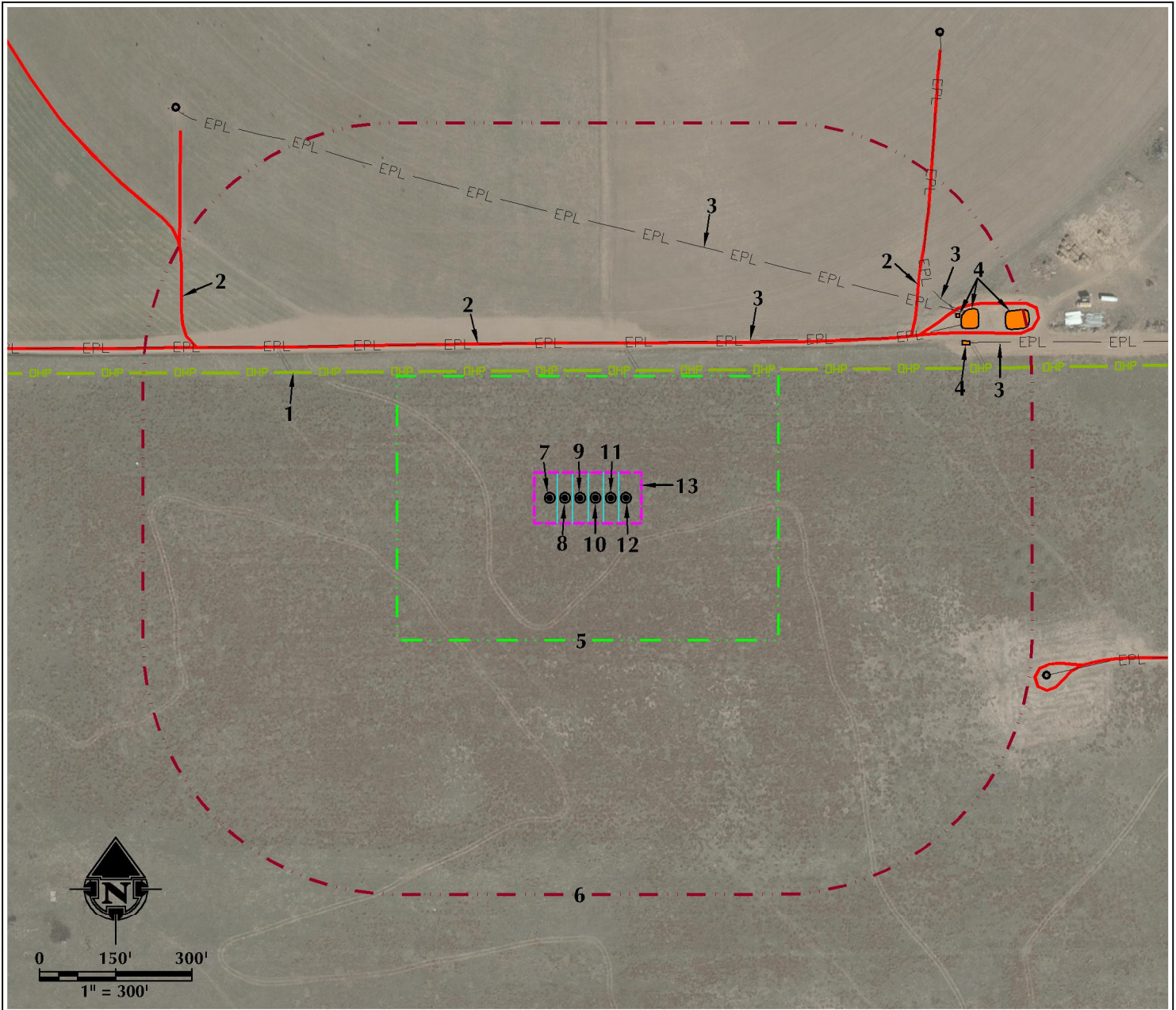


LOCATION DRAWING ADAMSON 14N-28HZ HORIZONTAL MULTI-WELL PAD
