#### COMMENTS:

A complete gas sample analysis is attached.

Gas was flared for 8 days during a 30-day period beginning October 3, 2014. The average flaring volume was 60.51 MCF/D; volumes were measured daily. A pipeline connection was established on October 4, 2014 and gas has been flowing to sales. Frequency of flaring decreased as the flowback and maintenance phase of the well was completed.

There is a presence of H2S; sampling showed 0.75ppm.
