#### COMMENTS:

Due to engineering concerns and emerging data, the SHL of this well has been revised to minimize surface impact and maximize efficiencies. Noble Energy certifies that there are no other changes to the permitted well, other than the SHL & the total depth of the well. The top of production, BHL, Lease, Spacing, and Pooling information will not change. Revised plat and directional plan attached. Noble Energy shall isolate the Upper Pierre Aquifer from the Fox Hills Aquifer with surface casing and cement and utilize intermediate casing and cement to ensure isolation from below.
