The RGU 332-26-198 well sundried BHL is located approximately 75' from the RGU 322-26-198 permitted BHL currently, but the BHL of the RGU 322-26-198 well and other wells on the RGU 22-26-198 PAD and RGU 11-26-198 pad are currently being revised by well planning and will be sundried. The changes made to the bottom hole locations of wells on the RGU 22-26-198 and RGU 11-26-198 pads will be spaced appropriately for anti-collision and proper drainage of the reservoir with appropriate spacing from the wells on the RGU 42-26-198 pad.
