- 160 acres

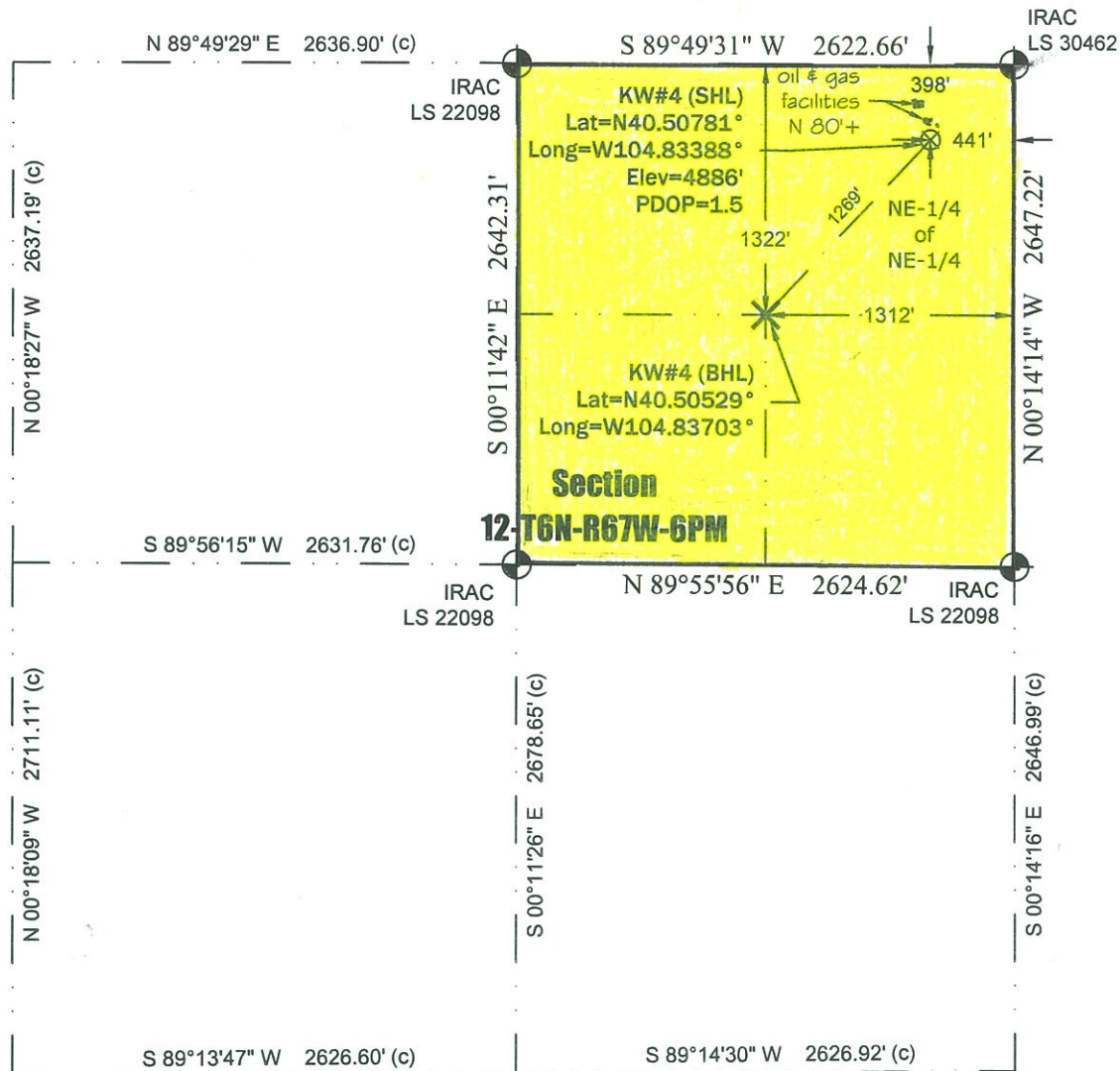
