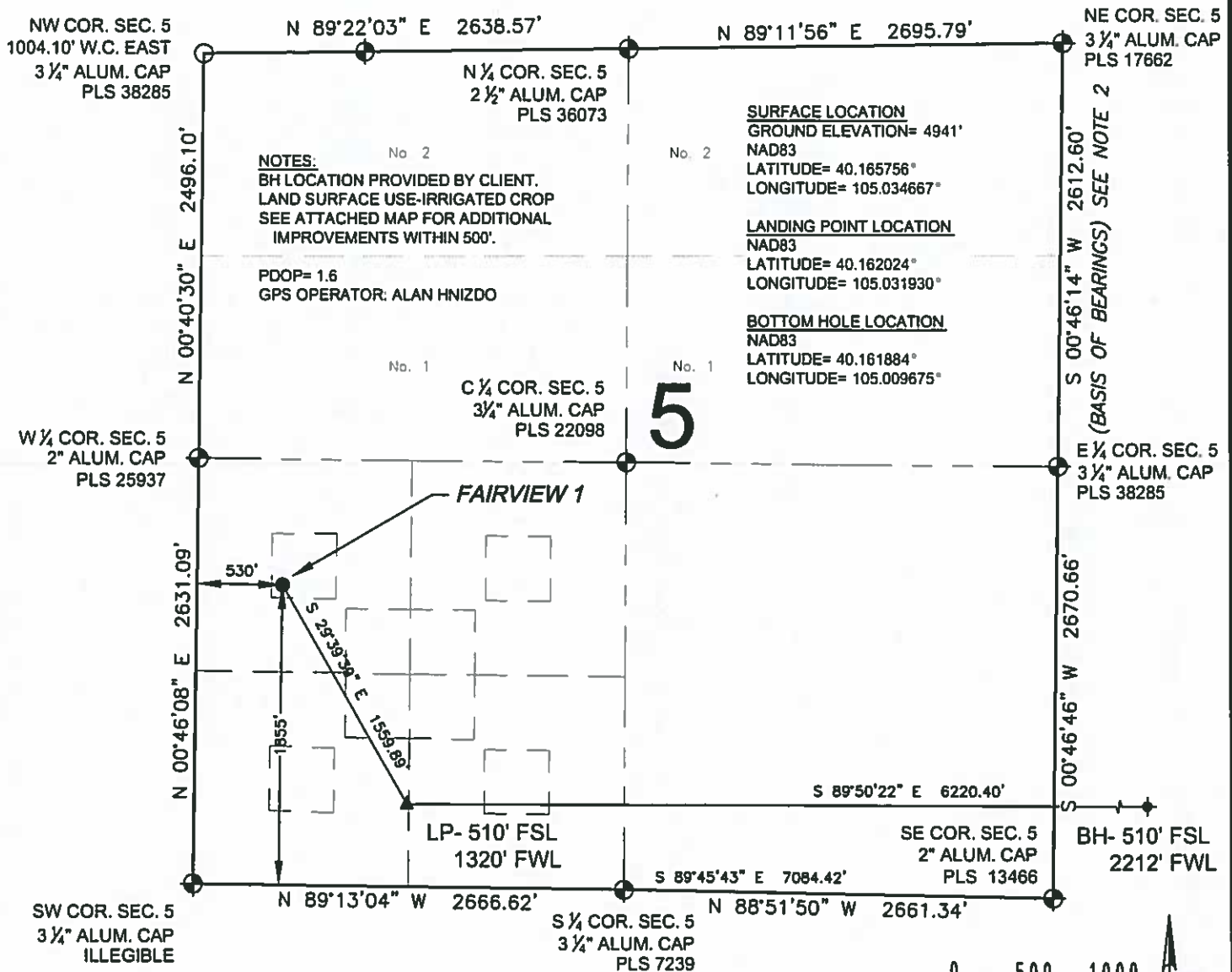


WELL LOCATION CERTIFICATE: FAIRVIEW 1

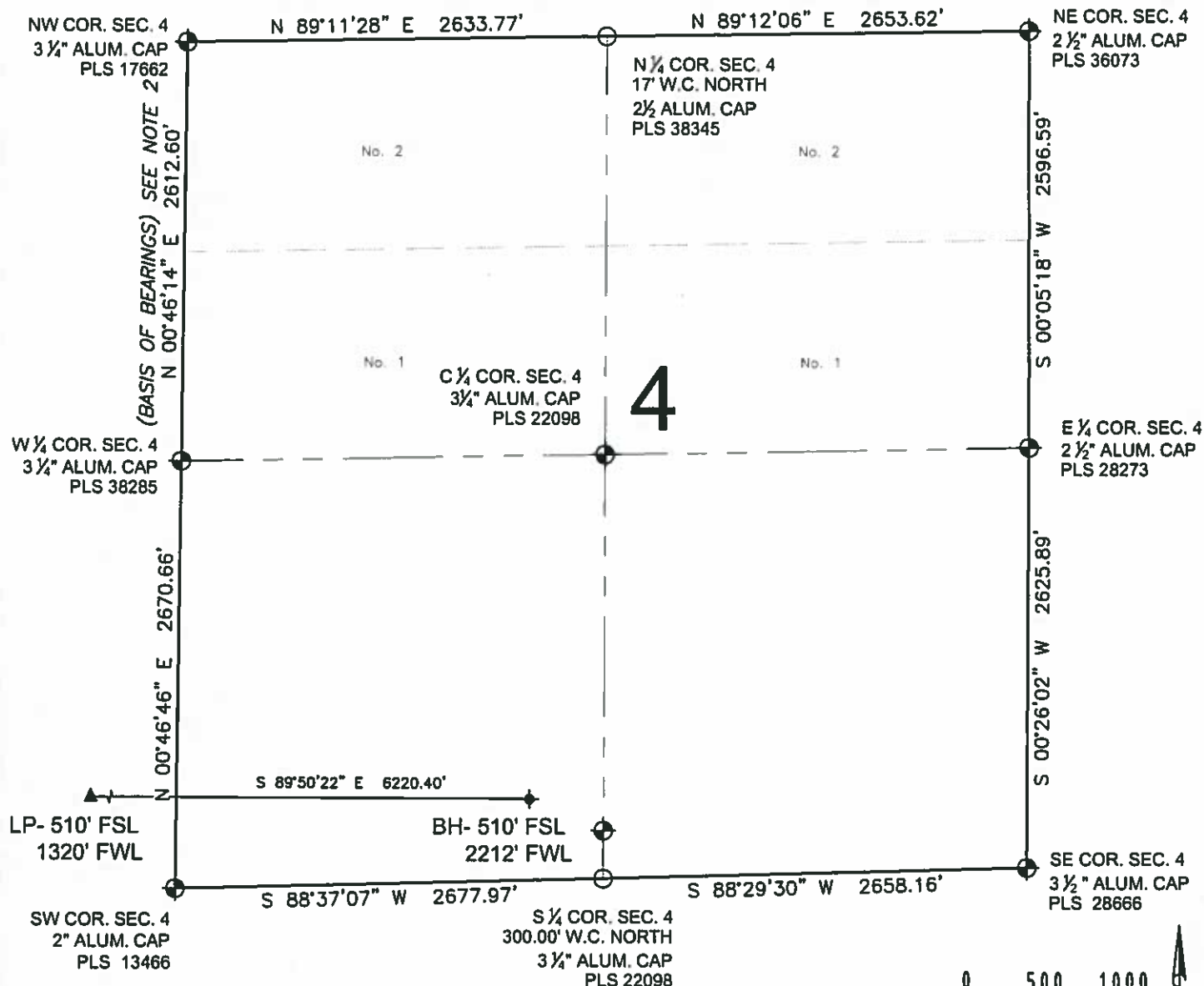
