COMMENTS:

This form is being submitted to document onsite burial of drill cuttings during pit closure and interim reclamation efforts carried out in November, 2011 on the E16 596 well pad (335812).

Following acquisition of multiple locations by Encana in 2010, drill cuttings stockpiles were characterized by collection of representative composite samples submitted to a laboratory for analysis of COGCC Table 910-1 constituents of concern. Pit closure and characterization activities were also initiated as part of this effort, with the below-grade pit excavations used for cuttings burial where possible.

The E16 596 storage pit closure was carried out under an approved remediation project (rem: 7759). In addition to the drill cuttings documented in the Notification of Completion (doc: 400805380) submitted for the pit closure, two additional cuttings stockpiles were also buried in the E16 596 pit excavation.

- B16 596 (335967) – 1,200 cubic yards
- G21 596 (414390) – 1,500 cubic yards

The transfer of these stockpiles was carried entirely upon Encana owned surface and roads.

The metal constituent arsenic is above the allowable limit, but is within the range of background values for this area. Based on these results and Footnote 1 to COGCC Table 910-1, Encana requests that the COGCC consider the higher range of background arsenic values as the allowable concentration for this constituent.

The inorganic constituents SAR and pH were also above allowable limits, but the cuttings stockpile was buried below the agronomic zone where these constituents should have no effect on revegetation efforts. Encana requests that the COGCC consider the reclamation purpose of listing the inorganic constituents and the physical disposition of these materials as an alternative to the allowable levels listed in COGCC Table 910-1.
