15 DATE OF WORK December 8-9, 1994

Late in the afternoon of December 8, 1994 (while the well was shut-in) the 300 barrel production tank was being hotoil treated. The heated oil released entrained gas in this high paraffin content crude oil and caused the tank to "cough" 6.68 barrels of oil (earlier reported as 5.75 bbls. of oil) out of the tank's "thief hatch". The majority of spilled oil was contained inside the berm. Stained soil outside the berm was picked up and placed inside the berm and the tank steam cleaned. All contaminated soil is now contained inside the berm and will be bioremediated by Olympic Environmental. The following parties were contacted within 24 hours of the spill: Mr. Ed Herring of the Weld County Sheriff's Department & Mr. Loren Avis of the Colorado Oil & Gas Conservation Commission.
