Comment: Zero press on BrH, csg and tbg; sting into cmt rtmr set at 1442'; pressure up to 625 psig and unable to pump into perfs; driller was uncomfortable in exceeding that pressure with pump. The decision was made to revise plans by spotting 20 sx cmt on top of retainer (see change order). Spot 21.4 sx cmt 1172'-1452'. Cut 9 5/8" & 4 1/2" csgs 3' below grade & retrieve csgs + the heads. Spot surface cmt plugs (14 sx) by running 1 3/8" OD tbg to a depth of 37'. Fill remainder of the rat hole still in place from the time the well was drilled with 8 sx cmt. Weld on a plate type PA marker w/ well information.
