PROCEED IN AN EASTERLY, THEN SOUTHEASTERLY DIRECTION FROM GREELEY, COLORADO ALONG US HIGHWAY 34 APPROXIMATELY 25.4 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD 87 TO THE NORTH; TURN LEFT AND PROCEED IN A NORTHERLY, THEN EASTERLY DIRECTION APPROXIMATELY 3.0 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD 89 TO THE NORTH; TURN LEFT AND PROCEED IN A NORTHERLY DIRECTION APPROXIMATELY 4.7 MILES TO JUNCTION OF THIS ROAD AND AN EXISTING ROAD TO THE WEST; TURN LEFT AND PROCEED IN A WESTERLY DIRECTION APPROXIMATELY 5.4 MILES TO THE BEGINNING OF THE PROPOSED ACCESS ROAD FOR THE ANSCHUTZ STATE 5-62-22_23 NWNW PAD TO THE NORTH; FOLLOW ROAD FLAGS IN A NORTHERLY DIRECTION APPROXIMATELY 788' TO THE BEGINNING OF THE PROPOSED ACCESS ROAD TO THE WEST; FOLLOW ROAD FLAGS IN A WESTERLY DIRECTION APPROXIMATELY 183' TO THE PROPOSED LOCATION.

TOTAL DISTANCE FROM GREELEY, COLORADO TO THE PROPOSED LOCATION IS APPROXIMATELY 38.7 MILES.
