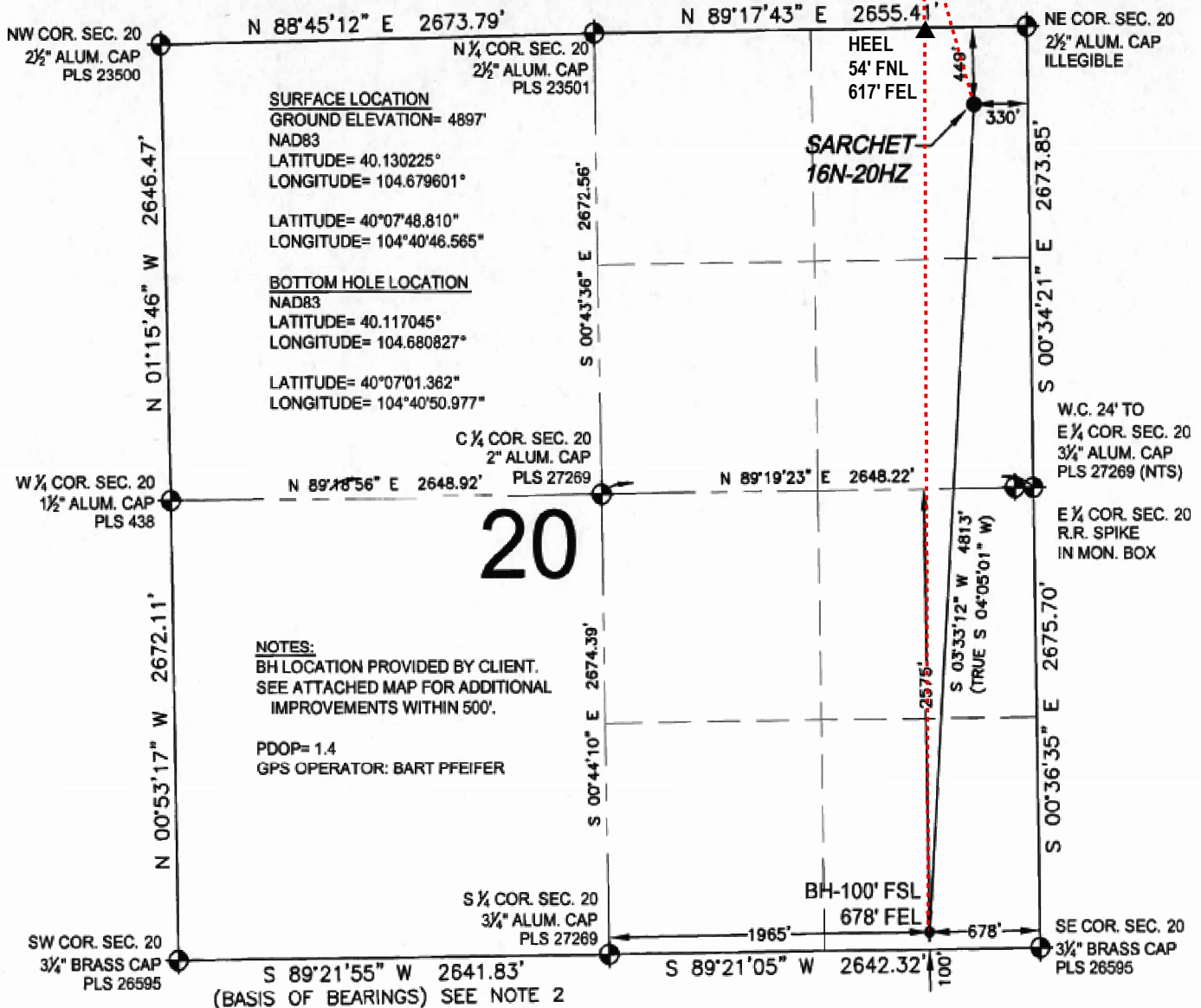


WELL LOCATION CERTIFICATE: SARCHET 16N-20HZ

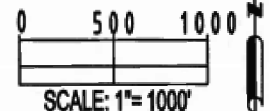
SECTION 20, TOWNSHIP 2 NORTH, RANGE 65 WEST, 6TH P.M.

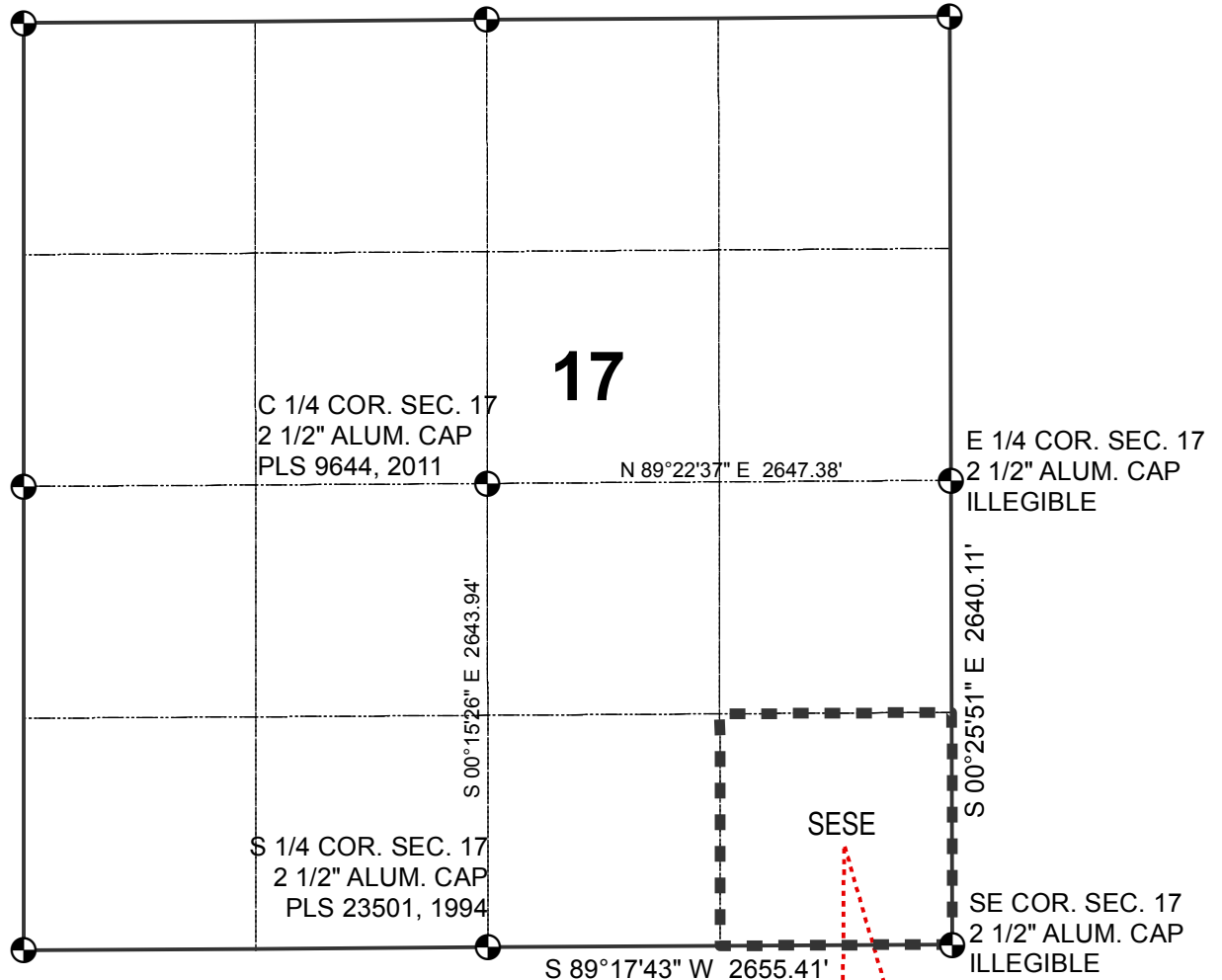
