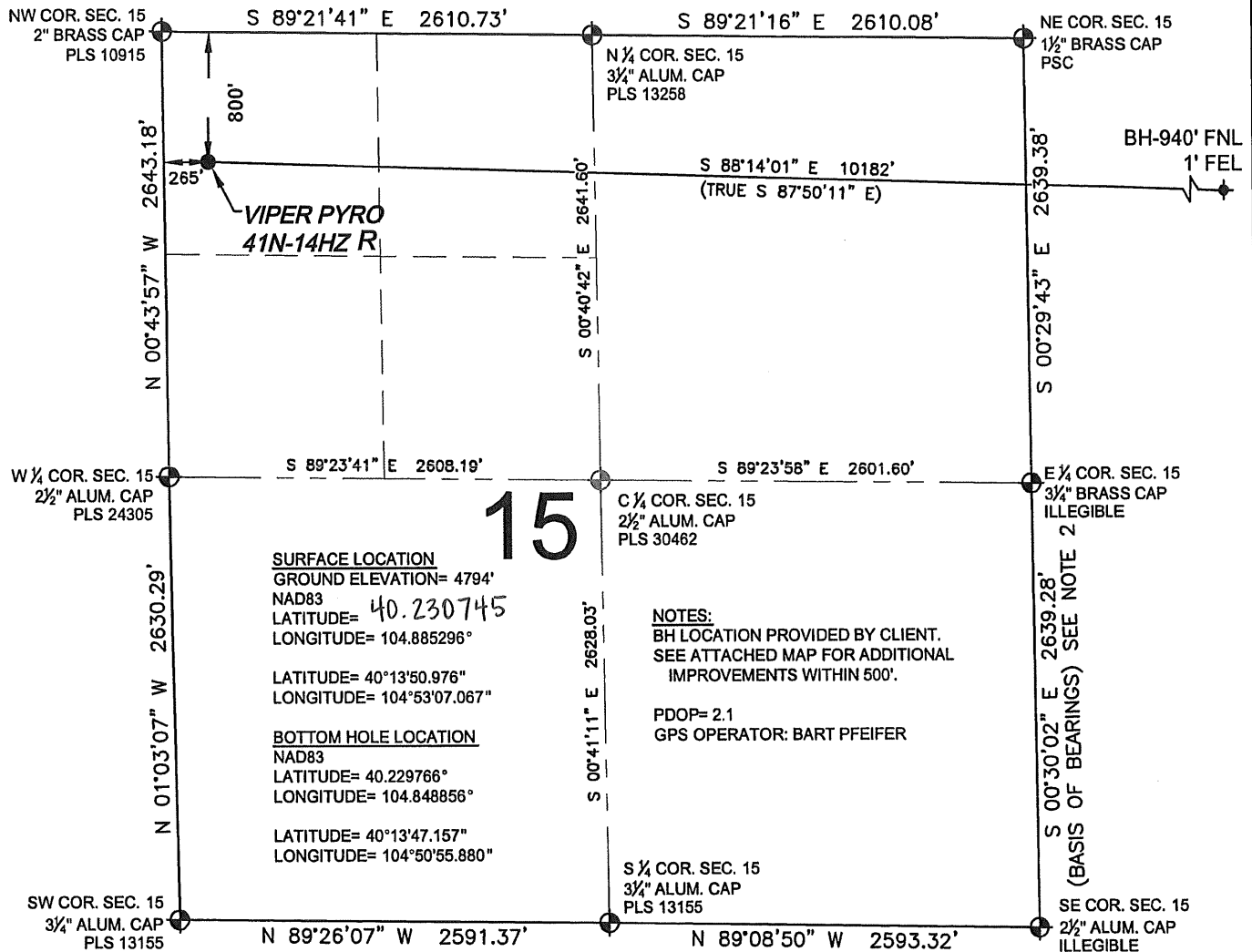


# WELL LOCATION CERTIFICATE: VIPER PYRO 41N-14HZ R

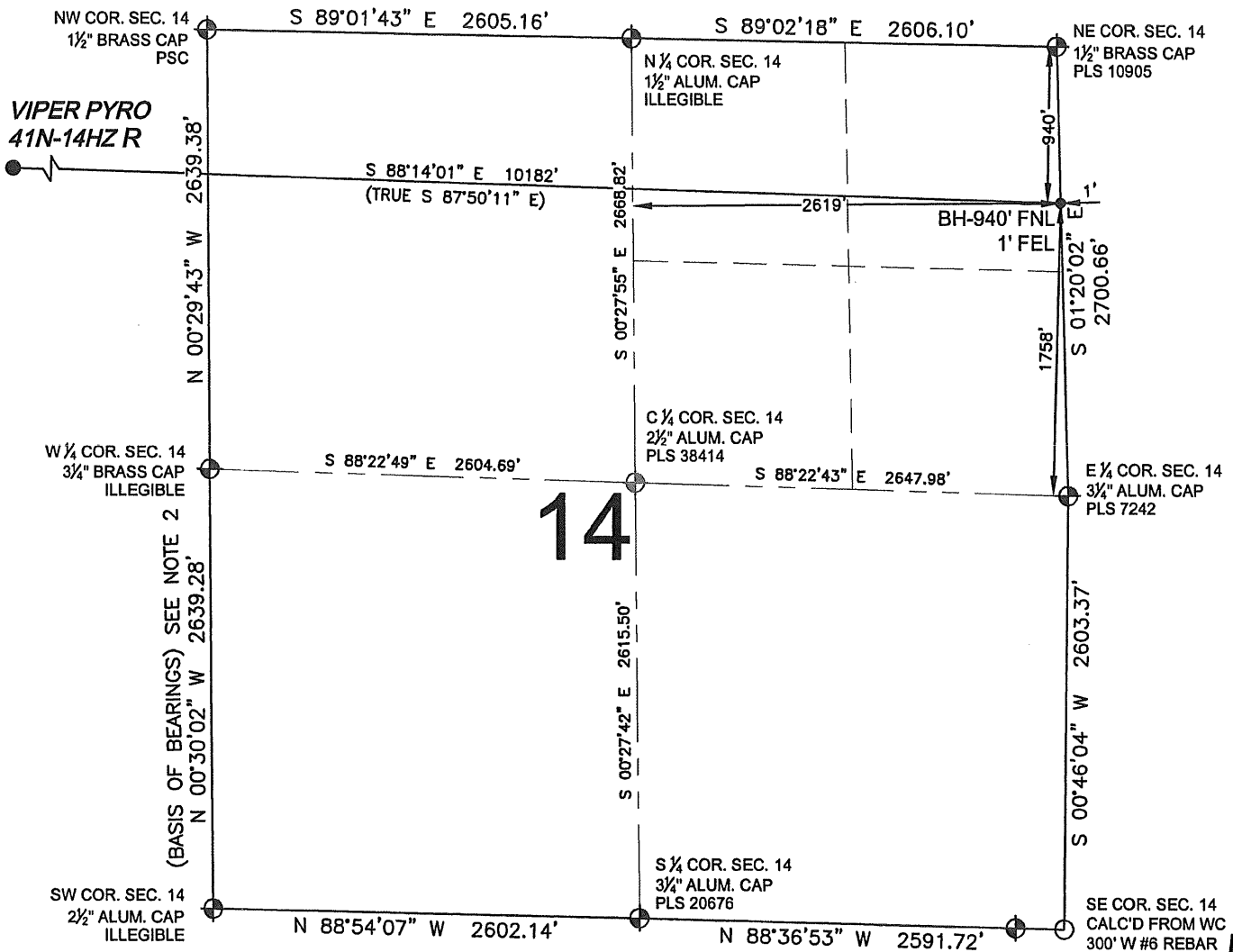
