Additionally, less than 50 Scotch thistle and Canada thistle plants were observed along the flowline. Diffuse knapweed, Scotch thistle, and Canada thistle are State and County-listed noxious weeds. Weeds need to be treated at the appropriate time but no later than seedhead maturity in 2015.

Comment	User	Date
Location does not meet reclamation regulations. The population of diffuse knapweed along the flowline right of way is one of only two-known populations of diffuse knapweed within La Plata County. This population should be eradicated. We recommend coordinating with La Plata County Weed Manager, Rod Cook to effectively control the infestation. Weeds need to be controlled at the appropriate time but no later than seedhead maturity in 2015.	RoyC	06/12/2015

## **ACTION REQUIRED**

**ANY ACTION REQUIRED** items listed on this report indicate that the oil and gas facility or the oil and gas operations listed on the report may be in violation of the rules and regulations of the Colorado Oil and Conservation Commission (“COGCC”) and corrective action is required.

There is reasonable cause to believe that a violation of the Oil and Gas Conservation Act, or of any rule, regulation, or order of the Commission, or of any permit issued by the Commission, has occurred. The Operator’s compliance with this Inspection Report is required to resolve these alleged violations. This document requires the Operator to timely respond to the COGCC and to comply with directives as listed by the **Corrective Action Deadline Date**. Failure to do so will result in the issuance of a Notice of Alleged Violation and initiation of enforcement proceedings in which COGCC will seek monetary penalties for the alleged violations pursuant to § 34-60-121, C.R.S. and Rule 523, COGCC Rules of Practice and Procedure, 2 CCR 404-1. (Please note that the COGCC's penalty authority was recently increased to a maximum of \$15,000 per day and penalties are no longer capped at a maximum of \$10,000 per violation.)
