H2S detection was made using a personal meter on 5/20/2015 date. This detection was at an open tank during swab operations. Upon detection swabbing and follow-up samples were taken according to the rule and swabbing operations ceased. These samples were taken from the wellhead at zero gauge pressure. No gas flow was possible without swabbing and an open flow reading was not possible to obtain.

Once swabbing and lift operations were resumed precautions were taken in accordance with rules and company policy. Water is being produced to a tank. Atmospheric release would be possible via this tank. No other detections of H2S have occurred. The results of the three wellhead samples show a single result above detection limit and in accordance with the rule these results are being provided.
