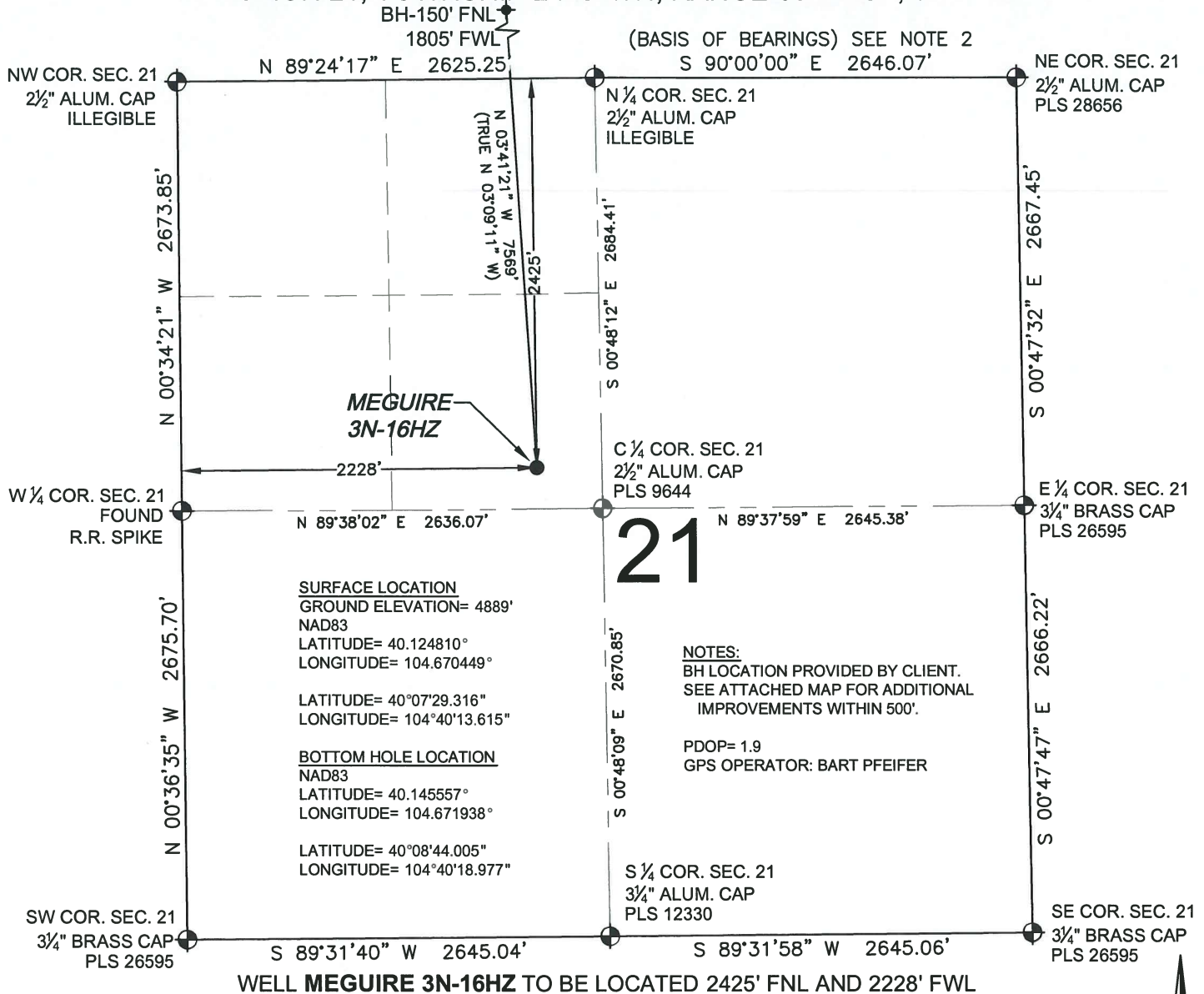

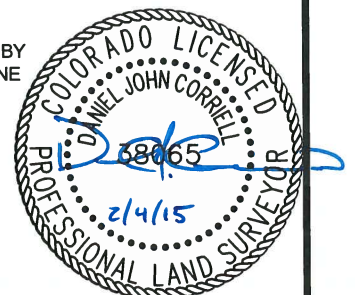
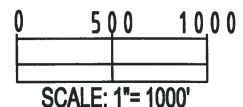
- ⊕ = EXISTING MONUMENT ♦ = BOTTOM HOLE

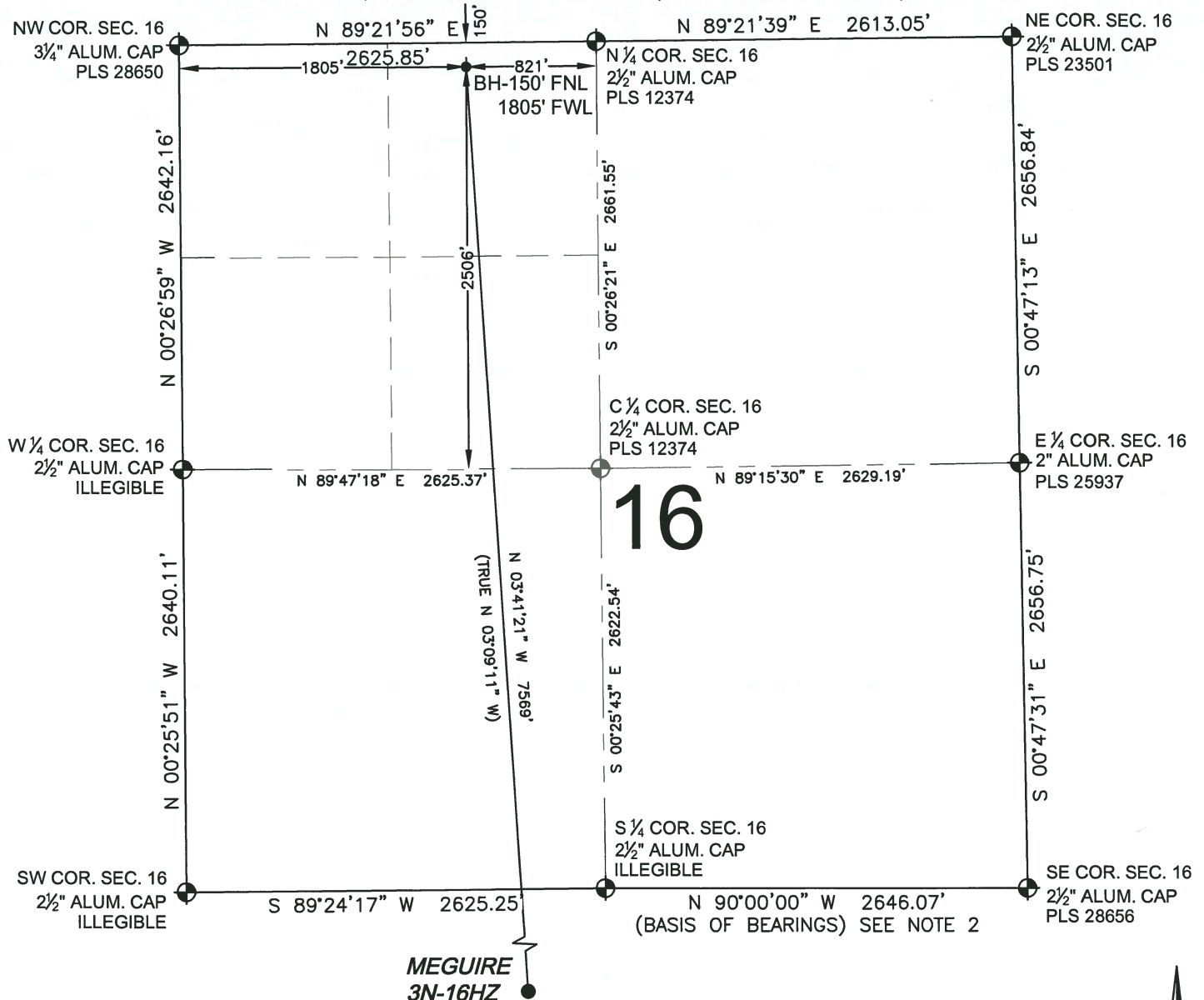
