Performed casing repair and confirmed integrity by witnessed MIT performed on 06-12-2015 (Form 42 400851890, Field Inspection 673710626, Form 21 400853980).

Verified that there is adequate isolation between the producing formation (J Sand) and the aquifer. The CBL indicates that the TOC is at 6800' and not at 6400' as requested on COA of Form 4 (Doc No 400843482) approved on 05-26-2015. KPK requests that no further cement coverage be required as casing repair is providing proper isolation between the producing formation and the aquifer. Additionally, there is no Niobrara production in the area and geologic information does not indicate that there is any potential for it.
