Mr. Lepore:

Bonanza Creek Energy, Inc. ("Bonanza") intends to drill the above referenced horizontal oil and gas wells to the Niobrara and/or Codell Formations, from a well pad to be located as described above. The proposed location is being permitted as an Exception Location, outside of a Wattenberg Window, in an effort to optimize the lateral length of the associated horizontal wells. Bonanza Creek has obtained written permission in a waiver from the surface owner.

Additionally, under Rule 318A.c, any new twinning well is to be located within 50 feet of an existing well. Bonanza has obtained permission, contained in a waiver from the surface owner, to locate the proposed wellhead greater than 50 feet from an existing well.

Thank you for your attention to this matter. Bonanza respectfully requests that the COGCC review the enclosed information and approve the Exception Location Request and Application for Permit to Drill the captioned well(s).
