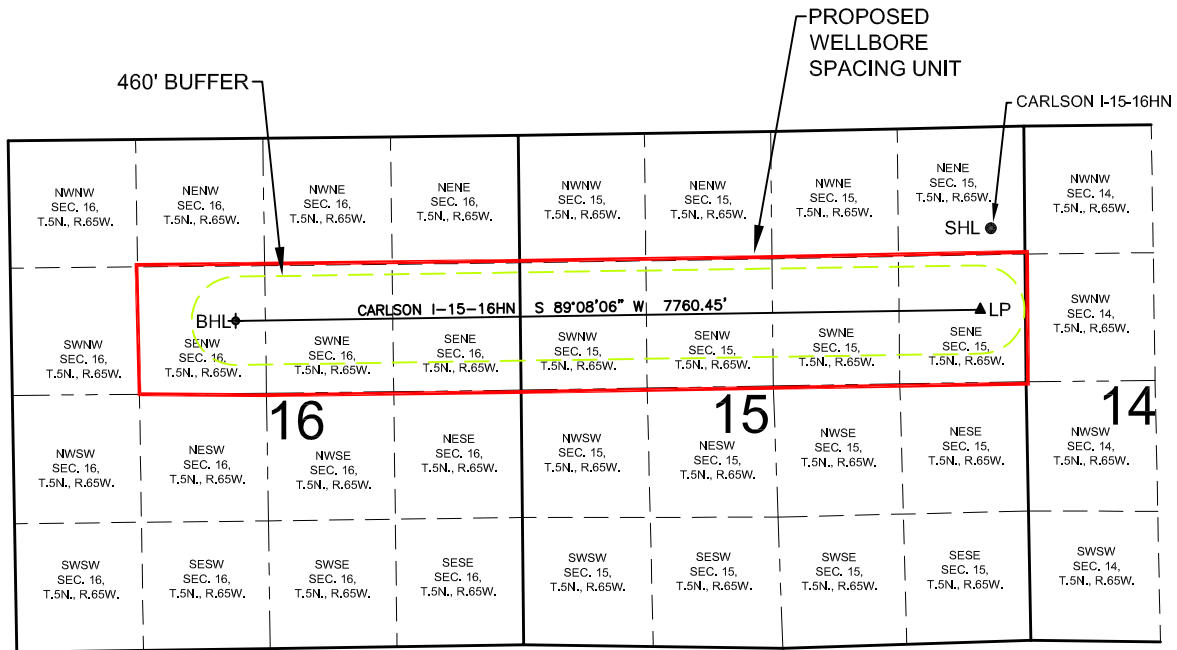

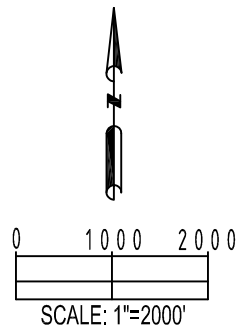
**CARLSON 15-D PAD**
