Comments First string top of cement = 200' above the Niobrara formation. The production liner will be hung off inside of the 7" casing string. 7 Well Pad includes, Wells Ranch AE32-670, AE32-665, AE32-655, AE32-650, AE32-645, AE32-640, and AE32-635.
Noble Energy shall isolate the Upper Pierre Aquifer from the Fox Hills Aquifer with surface casing and cement and utilize intermediate casing and cement to ensure isolation from below. Nearest Well is the Wells Ranch AE32-640.

If spills occur prompt cleanup is required to minimize any commingling of waste materials with stormwater runoff. Routine maintenance will be limited to fueling and lubrication of equipment. BMP's will be constructed around the perimeter of the site prior to, or at the beginning of construction. BMP's used will vary according to the location, and will remain in place until the pad reaches final reclamation.</p>

The horizontal portion of every well will be logged with a measured while-drilling gamma-ray log.
