Based on the information provided, the pit appears to have been reclaimed in accordance with COGCC rule 1004 b. and there is no indication that an investigation or remediation activities are required for the site. Noble requests a change to close the former pit associated with the BYDALAK-61S68W /11NENW (320191) facility.
