This variance request has been denied.

This oil and gas location has not completed Final Reclamation approval per COGCC 1000 Series rules. This variance request to re-use a portion of the location for a

retention pond extends the Final Reclamation approval outside the authority of the COGCC to grant approval.

Prior to granting this variance the operator must provide a geologic hazard evaluation of the location and area, a Reclamation Plan that includes the full location reclamation and

a demonstration of State Engineers Office approval of a pond at the site, the depth of the pond, earthen dam stability and the Division of Water Resources approval to capture and hold water.
